Subject: An Outline of the Chief Executive Officer's Recommendations for Changes to School Boundaries and Grade Structures

Abstract and Highlights: Board of Education Policy 0113 authorizes the Chief Executive Officer to develop a system of school boundaries that best utilizes available school facilities in support of the Board of Education's academic objectives, while Board Policy 5110.2 provides guidance for the formation of those boundaries. In addition, Board Policy 2570 directs the systematic study of the current and projected use of all educational facilities and, with regard to the efficient utilization of space and the effective delivery of instruction, to reassign students accordingly when necessary and practicable. In accordance with these policies, the Chief Executive Officer recommends the following boundary changes and grade structure changes for adoption by the Board of Education. Public hearings will be held virtually on the recommendations on October 20, 2022, and October 25, 2022.

The Comprehensive School Boundary Initiative commenced in August 2020. The initiative is an effort to balance enrollment at existing schools, create boundaries for new and expanded schools, and identify potential elementary school consolidations. The initiative creates boundaries for three new and six expanded facilities set to open in school years 2022-2023 through 2024-2025.

The first phase of the project was structured around a set of key components: a project website, direct outreach and a series of virtual Community Conversations. This allowed for the sharing of the district's challenges and an understanding of community priorities related to school boundaries. Using what was learned from the initial engagement and analysis of data, three draft boundary scenarios were developed and a comprehensive report was released in spring 2021.

The second phase commenced in October 2021. It consisted of a second round of community engagement around the draft scenarios report. The engagement efforts included five community conversations, an interactive online boundary tool and an online survey. Following this round of engagement, Scenario 2 was selected as the preferred option and refined based on public input and district priorities.

The final recommended changes by street address range are available in the supporting documentation. Recommended changes would be implemented in school years 2023-2024 and 2024-2025, subject to the projected completion dates of current capital projects. The schools listed below are those impacted by a boundary change or reassignment of sixth grade from elementary to middle school.

Boundary changes impacting fewer than 20 students that were considered in the preliminary plan are not recommended for adoption. Those include: Bond Mill Elementary to Scotchtown Hills Elementary; Carmody Hills Elementary to Seat Pleasant Elementary; Cora L. Rice Elementary to Highland Park Elementary; Deerfield Run Elementary to Montpelier Elementary; Flintstone Elementary to Oxon Hill Elementary; Fort Washington Forest Elementary to Clinton Grove Elementary; Francis Scott Key Elementary to Longfields Elementary; Gladys Noon Spellman Elementary to Cooper Lane Elementary; Greenbelt Middle to William Wirt Middle; Hillcrest Heights Elementary to Princeton Elementary; Hyattsville Elementary to Riverdale Elementary; Panorama Elementary to Barnaby Manor Elementary; Tayac Elementary to Apple Grove Elementary; Waldon Woods Elementary to Clinton Grove Elementary; and Whitehall Elementary to Rockledge Elementary.

Grandfathering clause – rising fifth and rising eighth grade students impacted by a boundary change will have the option to complete the terminal grade at their current school. Siblings of students in the terminal grade will also be permitted to remain at the current school for that year only. Transportation to the current school will be the responsibility of the parent or guardian.

Budget Implications: No net impact; school operating funds will be aligned with actual enrollments.

Staffing Implications: No net impact; staffing will be aligned with actual enrollments.

WHEREAS, public input on boundary and grade structure has been obtained through community meetings, an online survey, and emails and telephone calls from parents, students, public officials and community members; and

WHEREAS, based on public input, the Chief Executive Officer has formulated recommendations on boundary and grade structure changes; and

WHEREAS, public hearings will be held to obtain public comment on the recommendations made by the Chief Executive Officer;

THEREFORE, BE IT RESOLVED, that the Board of Education of Prince George's County approves the Chief Executive Officer's recommendations to implement boundary and grade structure changes for the schools listed above.
