SUPPLEMENTAL GERSTEIN

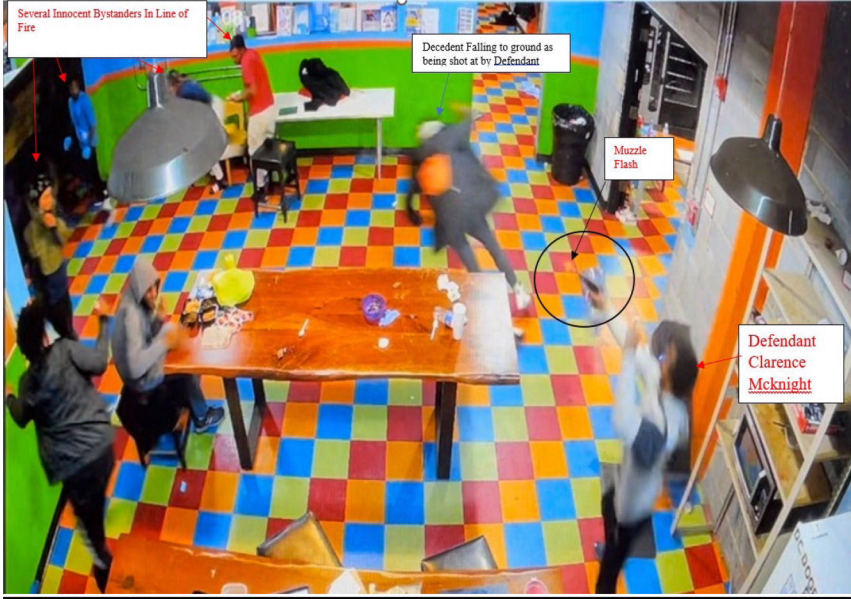
Your affiant can confirm that no weapons were recovered from the Decedent's person and/or near his body following the shooting by Defendant Clarence McKnight. Also, the video reviewed thus far does not show the Decedent brandishing a weapon at any time immediately prior to, during and/or after this homicide incident.

Your affiant would also like to correct an error in the Original Gerstein Affidavit. The last sentence under the portion summarizing Witness 1's account, should read that Witness 1 saw "an individual" on the ground, and not "a Defendant." So, the full sentence should read: "Witness 1 said IT turned around and saw an individual on the ground, but that IT did not realize it was the Decedent."

Below is a still photograph from an officer's Body Worn Camera showing some of the injuries to the Decedent's back. Based upon your affiant's over 22 years of law enforcement experience, these injuries appear to be consistent with entrance wounds.



Also, a still image from the DC Doors<sup>1</sup> video is included below that shows the Defendant firing towards (muzzle flash) the Decedent's back as he is running away and falling down. It also shows that there are several innocent bystanders in the line of fire who could have been struck as well.



On December 2, 2023, Dr. Fatima from OCME performed the decedent's autopsy. MPD Homicide Detective Braxton spoke with Dr. Fatima on the telephone. Dr. Fatima confirmed that the decedent suffered four (4) gunshot wounds to his body: Three (3) of the four (4) gunshot wounds entered the decedent's lower back area and traveled back to front; and the fourth (4<sup>th</sup>) gunshot wound entered the decedent's left side/flank and travelled left to right. The decedent had no gunshot wounds to the front of his body. Dr. Fatima determined that the cause of death was from multiple gunshot wounds to the body and ruled that the manner of death was HOMICIDE.
