COMPLAINT

The District of Columbia (the District) brings this action against Defendant Dejene A. Abebe under the Strengthening Traffic Enforcement, Education, and Responsibility Amendment Act of 2024 (STEER Act), D.C. Code § 50-2201.04(g)(1) and the Delinquent Debt Recovery Act, D.C. Code § 1-350.06(6), for numerous traffic infractions—many for dangerous and unsafe driving offenses—totaling \$58,608 in unpaid fines, penalties, and fees owed to the District. In support of its Complaint, the District states the following:

INTRODUCTION

1. Defendant Dejene A. Abebe is a threat to public safety. From July 2017 through October 2024, Defendant Abebe and her associated vehicle amassed 197 citations for traffic infractions across Defendant Abebe’s Virginia driver’s license and three different Virginia license plates. The vast majority of these citations—167—were accrued in a three-year period from 2021 through 2024. More than 80 percent of Defendant Abebe’s citations are for excessive speeding and other unsafe and dangerous driving in the District.

2. One hundred and sixty-three of Defendant's Abebe's 197 citations are for speeding. Of the 163 speeding citations, 107 citations are for driving 11-15 miles per hour above the speed limit, and 41 citations are for driving 16-20 miles per hour above the speed limit.

3. Additionally, of the 163 citations for speeding, 15 citations are for driving at speeds that constitute reckless driving, or driving 20 miles per hour or more above the speed limit. D.C. Code § 50-2201.04(b)(1).

4. Rather than resolve or pay the thousands of dollars in tickets she has amassed in just three years, Defendant Abebe has acted as if there are no consequences for her lawlessness. As of the filing date, Defendant Abebe owes the District \$58,608 in unpaid fines, penalties, and fees for her unsafe driving.

5. The District brings this action to hold Defendant Abebe accountable for her long history of unsafe driving, collect money she owes the District, and ensure she stops endangering others and threatening public safety.

JURISDICTION

6. This Court has subject matter jurisdiction under D.C. Code § 11-921(a) and D.C. Code § 50-2201.04(g)(1).

7. This Court has personal jurisdiction over Defendant Abebe under D.C. Code § 13-423(a)(3) because Defendant Abebe or an authorized driver was driving Defendant Abebe's vehicle in the District when the underlying traffic infractions occurred, and under D.C. Code § 50-2201.04(g)(1)(A).

PARTIES

8. Plaintiff the District of Columbia, a municipal corporation empowered to sue and be sued, is the local government for the territory constituting the permanent seat of the government

of the United States. The District is represented by and through its chief legal officer, the Attorney General for the District of Columbia. The Attorney General conducts the District's legal business and is responsible for upholding the public interest. D.C. Code § 1–301.81(a)(1).

9. Defendant Dejene A. Abebe resides in the State of Virginia at 2340 Carta Way Apt. 4003, Herndon, VA 20171.

10. Defendant Abebe is the sole, registered owner of a vehicle that is associated with three distinct Virginia license plates.

11. Defendant Abebe holds a Virginia driver's license.

12. Defendant Abebe received numerous traffic citations on each of the Virginia license plates and her Virginia driver's license that have accumulated fines, penalties, and fees because of her nonpayment.

**THE DEPARTMENT OF MOTOR VEHICLES AND THE CENTRAL
COLLECTION UNIT'S TRAFFIC INFRACTION DEBT COLLECTION PROCESS**

13. The District of Columbia's Department of Motor Vehicles (DMV) manages the process for collecting traffic fines and adjudicating traffic violations. D.C. Code § 50-904(1)(A).

14. The District issues a Notice of Infraction for violations of traffic laws and regulations. D.C. Code § 50-2303.03. A Notice of Infraction may be issued by either a law enforcement officer or an automated traffic enforcement system.¹ 18 DCMR § 3003.1; D.C. Code § 50-2209.01(a).

15. The owner of a vehicle issued a Notice of Infraction is liable for payment of the fine assessed for the infraction. D.C. Code § 50-2209.02.

¹ An automated traffic system is "equipment that takes a film or digital camera-based photograph which is linked with a violation detection system that synchronizes the taking of a photograph with the occurrence of a traffic infraction." D.C. Code §§ 50-2209.01(a), 2303.02a(a).

16. An individual who receives a Notice of Infraction may answer it by: (1) paying the fine; (2) admitting with an explanation; or (3) denying the infraction. D.C. Code §§ 50-2302.05(a), 2303.05(a)(1).

17. A civil fine for a traffic infraction varies based on the established amount for the offense. D.C. Code § 50-2301.05(a)(1); *see, e.g.*, 18 DCMR §§ 2600, 2601. A penalty equal to the civil fine is imposed on an individual who fails to answer a Notice of Infraction within 30 calendar days of the notice issuance date. D.C. Code §§ 50-2302.05(d), 2303.05(d)(1).

18. If an individual fails to answer a Notice of Infraction within 60 calendar days, the traffic infraction will be deemed admitted and all fines and penalties will be assessed. D.C. Code §§ 50-2302.05(e), 2303.05(d)(2).

19. An individual may apply to vacate an admission within 60 calendar days of the deemed admission date by providing a sufficient defense to the traffic violation and an excusable reason for the delay in answering the traffic violation.² D.C. Code §§ 50-2302.05(i)(1), 2303.05(f).

20. After 120 days from the notice issuance, the DMV may refer debt arising from unpaid traffic infractions to the Office of the Chief Financial Officer (OCFO) Central Collection Unit (CCU) for collection. D.C. Code § 1-350.02(a). Included in the DMV's referrals are both tickets that were not adjudicated and tickets that were adjudicated but where liability was found.

² For a traffic violation detected by an automated traffic enforcement device, an individual may apply to vacate a deemed admission within one year of the date of admission by providing a defense that they were not the owner or lessee of the vehicle involved or that the license plates were stolen at the time of the violation. D.C. Code §§ 50-2302.05(i)(3), 2303.05(g).

21. CCU is a component of the OCFO. CCU was established under the Delinquent Debt Recovery Act. D.C. Code § 1-350.01(1). It is responsible for collecting delinquent debt owed to the District.³ D.C. Code § 1-350.02(a).

22. CCU imposes a 20 percent collection fee to delinquent debt owed from an unpaid traffic ticket. *Central Collection Unit Fee*, District of Columbia OCFO, https://cfo.dc.gov/sites/default/files/dc/sites/ocfo/publication/attachments/CCU%20Fee_Assignment.pdf, (last visited Feb. 10, 2025).

23. The DMV and CCU use an electronic Ticketing Information Management System (eTIMS) to facilitate referrals. This system stores all traffic tickets issued by, among other agencies, the District of Columbia Department of Public Works (DPW), the District of Columbia Department of Transportation (DDOT), and the Metropolitan Police Department (MPD). Tickets stored in eTIMS include, but are not limited to, moving violations ticketed by an officer, violations captured by an automated traffic enforcement device, and parking violations.

24. ETIMS is equipped to retrieve information from various electronic systems within the District, Maryland, and Virginia, which includes the names and addresses of registered license plate owners.

25. ETIMS consolidates all traffic infractions under the associated driver's license number and license plate. For each driver's license and license plate, eTIMS captures the: (1) ticket number; (2) status of the ticket; (3) violation date and time; (4) violation code and description; (5) make of the vehicle; (6) location of the violation and disposition of the ticket; (7) fine amount; (8) penalty; and (9) total amount due.

³ Delinquent Debt is any financial obligation owed to the District by an individual that remains unpaid more than 90 days after it due. D.C. Code § 1-350.01.










26. CCU contracts with Harris & Harris, Ltd. (Harris & Harris), a third-party collection agency, to collect delinquent debt owed to the District. Harris & Harris communicates with debtors in the form of letters and phone calls to collect delinquent debt. Harris & Harris uses an electronic database that captures every attempt made to collect debt and every communication sent to and received from a debtor. The system also captures the total debt in collections that includes all fines, penalties and fees.

DEFENDANT DEJENE ABEBE'S OUTSTANDING TRAFFIC INFRACTIONS

27. CCU conducted an eTIMS search of Defendant Abebe's traffic infractions associated with her driver's license number and all license plate numbers registered in her name.

28. Defendant Abebe holds a Virginia driver's license number **VAB69617101**.

29. The District issued the following traffic citations to Defendant Abebe under driver's license number **VAB69617101**:

30. DMV records currently reflect that Defendant Abebe has nine delinquent traffic citations issued to her driver's license, totaling \$1,680.

31. DMV records reflect that, of the nine delinquent traffic citations, all but one are for dangerous driving. Of those nine citations two citations are for running red lights, one citation is










for running a stop sign, one citation is for failing to yield, one citation is failing to pay attention while driving, one is for using a cell phone while driving, one is for failing to stop completely before turning, and one is for turning from the wrong lane

32. Defendant Abebe has either failed to answer or resolve these traffic tickets, and thus liable for all fines, penalties, and fees for these traffic tickets.


33. Defendant Abebe is the sole registered owner of three distinct Virginia license plates on which she owes delinquent debt: **VAUJK1213**, **VAVJB8480**, and **VAB69617101**.

34. All license plates are associated with a 2015 Jeep Renegade Latitude with vehicle identification number (VIN) ZACCJABT9FPB98622.

36. DMV records currently reflect that Defendant Abebe has 167 delinquent traffic citations issued to this license plate, totaling \$51,672.

37. During a short three-year window from 2021 to 2024, Defendant Abebe amassed 148 of the citations for excessive speeding in the District. In 2023 alone, Defendant Abebe received 48 citations for speeding. Of the 148 citations for speeding, 97 citations were issued for driving 11-15 miles per hour above the speed limit, and 36 citations were issued for driving 16-20 miles per hour above the speed limit.


38. Additionally, of the 148 citations for speeding, 15 citations are for driving at speeds that would constitute reckless driving, or driving 20 miles per hour or more over the speed limit. D.C. Code § 50-2201.04(b)(1).

39. Defendant Abebe also received traffic citations for other dangerous and unsafe driving infractions. Of the 167 traffic citations issued on this license plate, nine citations were issued for running red lights, and two were issued for running stop signs.

40. Defendant Abebe failed to answer and thus was deemed liable for all fines, penalties, and fees for these traffic infractions.

41. As of the filing date, Defendant Abebe owes the District \$51,672 for traffic citations issued under license plate **VAUJK1213**.

42. The District issued the following traffic citations to Defendant Abebe under license plate number **VAVJB8480**:

43. DMV records currently reflect that Defendant Abebe has 17 delinquent traffic citations issued to this license plate, totaling \$4,056.

44. DMV records reflect that, of the 17 traffic citations, 12 citations were for unsafe and dangerous driving infractions. Of those citations, eight traffic citations were issued for driving 11-15 miles per hour above the speed limit; three traffic citations were issued for driving 16-20 miles per hour above the speed limit; and one traffic citation was issued for running a red light.

45. Defendant Abebe failed to answer and was thus deemed liable for all fines, penalties, and fees for these traffic infractions.

46. As of the filing date, Defendant Abebe owes the District \$4,056 for traffic citations issued under license plate **VAVJB8480**.

47. The District issued the following traffic citations to Defendant Abebe under license plate number **VAU23298**:

48. DMV records currently reflect that Defendant Abebe has four delinquent traffic citations issued under this license plate, totaling \$1,200.

49. DMV records reflect that all citations were for dangerous driving. All citations were issued for driving 11-15 miles per hour above the speed limit.

50. Defendant Abebe failed to answer and was thus deemed liable for all fines, penalties, and fees for these traffic infractions.

51. As of the filing date, Defendant Abebe owes the District \$1,200 for traffic citations issued under license plate **VAU23298**.

52. In total, Defendant Abebe has 202 delinquent traffic citations and owes the District \$59,928 in outstanding debt for failure to answer or otherwise pay the fines, penalties, and fees associated with her driver's license and registered license plates.

53. The DMV contacted Defendant Abebe by mail, notifying her of each traffic infraction, the associated penalties, and the associated period to resolve each infraction. Overall, the DMV allotted Defendant 120 days from the date of each Notice of Infraction to contest or resolve any associated fines and penalties.

54. Due to Defendant Abebe's failure to resolve the traffic citations with the DMV, the DMV referred Defendant's unpaid fines and penalties to CCU.

55. CCU, through Harris & Harris, attempted to collect the underlying delinquent debt on multiple occasions by telephone and postal mail but was unsuccessful.

56. On October 24, 2024, CCU sent Defendant Abebe a final demand letter notifying her of the unpaid delinquent debt and providing information on how to resolve it. Defendant Abebe failed to resolve the delinquent debt with CCU.

57. Thereafter, CCU referred this matter to the Office of the Attorney General for the District of Columbia to initiate a civil action to collect the debt.

COUNT I
VIOLATION OF THE STRENGTHENING TRAFFIC
ENFORCEMENT, EDUCATION, AND RESPONSIBILITY AMENDMENT ACT
D.C. CODE § 50-2201.04

58. The District incorporates by reference all allegations stated as previously set forth in paragraphs 1-57.

59. The District may bring a civil suit against any driver, or any motor vehicle alleged to have been driving at a rate of speed over a designated speed limit. D.C. Code § 50-2201.04(g)(1).

60. The owner of a registered vehicle is liable for payment of any fine and penalties associated with a traffic infraction. D.C. Code § 50-2209.02(a); *see also* D.C. Code § 50-2302.05(e) ("If a person fails to answer the notice within 60 calendar days after the date the notice was issued, . . . the commission of the infraction shall be deemed admitted and all points, penalties, and fines shall be assessed.")

61. At all relevant times, Defendant Abebe was the registered owner of Virginia vehicle license plates **VAUJK1213**, **VAVJB8480**, and **VAU23298**.

62. The District issued 148 speeding citations to Defendant Abebe under license plate number **VAUJK1213**.

63. Defendant Abebe failed to answer and thus is liable for all fines, penalties, and fees for these speeding infractions.

64. As of the filing date, Defendant Abebe owes the District \$46,320 for 148 delinquent speeding citations out of the total \$51,672 debt under license plate number **VAUJK1213**.

65. The District issued citations for 11 speeding infractions to Defendant Abebe under license plate number **VAVJB8480**.

66. Defendant Abebe failed to answer and was thus deemed liable for all fines, penalties, and fees for these speeding infractions.

67. As of the filing date, Defendant Abebe owes the District \$3,000 for 11 delinquent speeding infractions out of the total \$4,056 debt under license plate number **VAVJB8480**.

68. The District issued citations for four speeding infractions to Defendant Abebe under license plate number **VAU23298**.

69. Defendant Abebe failed to answer and was deemed liable for all fines, penalties, and fees for these speeding infractions.

70. As of the filing date, Defendant Abebe owes the District the entire \$1,200 for all four delinquent speeding infractions under license plate number **VAU23298**.

71. In total, Defendant Abebe has 163 delinquent speeding citations and owes the District \$50,520 in outstanding debt for failure to answer or otherwise pay the associated fines, penalties, and fees with her registered Virginia license plates.

COUNT II
DEFENDANT'S DELINQUENT DEBT UNDER
THE DELINQUENT DEBT RECOVERY ACT
D.C. CODE § 1-350.06

72. The District incorporates by reference all allegations previously set forth in paragraphs 1-71.

73. CCU, in its discretion, may refer delinquent debt owed to the District to the Office of the Attorney General for civil enforcement. D.C. Code § 1-350.06(6).

74. CCU has referred to the Office of the Attorney General Defendant Abebe's delinquent debt arising from her nonpayment of 197 delinquent traffic citations.

75. As of the filing date, Defendant Abebe owes the District \$1,680 for traffic citations issued under driver's license **VAB69617101**.

76. As of the filing date, Defendant Abebe owes the District \$51,672 for traffic citations issued under driver's license **VAUJK1213**.

77. As of the filing date, Defendant Abebe owes the District \$4,056 for traffic citations issued under license plate **VAVJB8480**.

78. As of the filing date, Defendant Abebe owes the District \$1,200 for the traffic citation issued under license plate **VAU23298**.

79. As Defendant Abebe has failed to answer the traffic citations associated with her Virginia driver's license and registered Virginia license plates with the DMV noted above, Defendant Abebe owes the assessed fines, penalties, and fees to the District. The District now seeks \$58,608 from Defendant Abebe for all delinquent debt owed to the District arising from Defendant's outstanding traffic citations set forth in this Complaint.

PRAYER FOR RELIEF

Wherefore, the District respectfully requests that the Court enter judgment in its favor and against Defendant as follows:

- (1) Award the District \$58,608 for Defendant Abebe's unpaid fines, penalties and fees;
and
- (2) Award reasonable attorney's fees; and
- (3) Award the District such further and additional relief as the Court may deem just and proper.
